If there was approval tonight, I think it would probably have to be a conditional approval to submit all these elements. Chairman Diffendorf agreed that the Board should table this application tonight because there are many items that need to be addressed.

Kevin Balachick said that without the owner being here really there isn't much we can do. Chad Moran stated the owner just sent him a text message and said he is stuck on a job and won't be able to make it tonight. Chairman Diffendorf said it's not like we are holding him up, they have been in the building all summer. Chairman Diffendorf asked the Board if anyone had any other questions.
